Discuss nominating process

Scott Harris discussed the nominating process. The nominating process was set up and established by the RFPG to fill voting and non-voting positions on the RFPG committee.

Consideration of a recommendation to the Full RFPG for the appointment to fill the vacant Voting position of Water District.

a. Allow each candidate for Water District – voting member position up to 10 minutes to explain why the nominating committee should recommend then to the full RFPG.

Jennafer P. Covington, Executive Director, North Texas Municipal Water District (NTMWD) provided a recommendation via email for Galen Roberts to serve as a voting member representing the water districts interest category on the R3FPG:

Galen Roberts is the Assistant Deputy of Water Resources at NTWMD. He is responsible for managing NTWMD water rights portfolio, lake and wetland operations, and watershed protection efforts. He has a strong background in watershed hydrology, water quality and stormwater and has spent much of his career in the service of NTWMD, a water district serving approximately 2 million people in North Texas. Galen's background and experience make him an ideal candidate to represent the water districts interest category and to help develop the first-ever regional flood plan for the Trinity River Basin.

Furthermore, Galen Roberts has been serving as an alternate for Mike Rickman on the RFPG committee.

 Member discussion, consideration and recommendation of individual to fill the Water District interest category position

Mr. Galen Robert, Assistant Deputy of Water Resources at NTWMD, was the only application received by the nominating committee for the vacancy. The committee reviewed the application and found it to be in order and that Mr. Galen is qualified to fill the seat as the representative for water districts.

After discussion of the candidate application and qualifications, the nominating committee reached consensus that Galen Roberts would be the recommended candidate carried forward to the full RFPG.

Scott Harris called for a motion to recommend Galen Roberts be nominated to fill the vacant water district interest position on the RFPG committee.

Motion: Andrew Isbell made a motion to recommend Galen Roberts be nominated to fill the vacant water district interest position on the RFPG committee; Second: Matt Robinson; Action: Motion passed unanimously.
